IF SWALLOWED:

- Call a poison control center, doctor, or 1-877-854-2494, or 1-800-858-7378** immediately for treatment advice.
- Have person sip a glass of water if able to swallow.

IF ON SKIN OR CLOTHING:

NOTE TO PHYSICIAN

If swallowed or absorbed through the skin, this material may reduce the clotting ability of the blood and cause bleeding. If ingested administer Vitamin K1 intramuscularly or orally. Repeat as necessary based on monitoring of prothrombin times.

TREATMENT FOR PET POISONING If animal eats bait, call veterinarian at once.

NOTE TO VETERINARIAN

Anticeogulant Bromadione: For animals ingesting bait and/or showing poisoning signs (bleeding or elevated profrom/bin times), give Vitamin Kr. If needed, check profrombin times every 3 days until values return to normal (up to 30 days). In severe cases, blood transfusions may be needed.

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

READ THIS LABEL: Read this entire label and follow all use directions and use precautions. Use only for sites, pests and application methods described on this label.

IMPORTANT: Do not expose children, pets, or nontarget animals to rodenticides. To help to prevent accidents

- 1. Store unused product out of reach of children and pets.
- 2. Apply bail in locations out of reach of children, pets, domastic anima's and nontarget wildfe, or in tamper-resistant bail stations. These stations must be resistant to distruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and chaining bat. If bait can be shaken from bail stations when they are lifted, units must be sedured or otherwise immobilized. Stronger bait stations are needed in areas open to hooled livestock, raccoons, bears, or other potentially destructive animals, or in areas prone to vandalism.

Do not place near or inside ventilation duct openings. Do not contaminate water, food, feedstuffs, food or feed handling equipment, or milk or meat handling equipment or surfaces that come into direct contact with food. When used in USDA inspected facilities, this product must be applied in tamper-resistant bail stations. Do not broadcast bait. Do not use this product in severs.

Do not sell this product in individual containers holding less than 16 pounds of bait.

SELECTION OF TREATIMENT AREAS: Determine areas where rats, mice or meadow voles' will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Protect bait from rain and snow. Henrove as much alternative food as possible.

APPLICATION DIRECTIONS:

RATS: Apply 2 to 10 Place Pacs at intervals of 15 to 30 feet per placement. Maintain an uninterrupted supply of fresh bait for at least 10 days or until signs of rat activity cease to appear.

MICE AND MEADOW VOLES*: Place 1 Place Pac at 8 to 12 foot intervals. Maintain an uninterrupted supply of fresh bait for at least 15 days or until signs of mouse or meadow vole* activity cease to appear.

FOLLOW-ÚP: Replace contaminated or spolled bait immediately. Wearing gloves, collect and dispose of all dead animals and leftoure bait properly. To prevent reinfestation, limit sources of rodent bod, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed or absorbed through skin. Causes moderate eye irritation. Do not get in eyes, on skin, or on clothing. Keep away from children, domestic animals and pets.

All handlers (including applicators) must wear long sleeved shirt and long pants, shoes plus socks, and waterproof gloves. Any person who retrieves carcasses or unused bait following application of this product must wear gloves.

User Safety Requirements

Follow manufacturer's instructions for cleaning/maintaining PPE. If no such instructions for washables exist, use detergent and hot water. Keep and wash PPE separately from other laundry. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash hands thoroughly after applying bait and before eating, drinking, chewing gum, using tobacco or using the toilet and change into clean clothing.

ENVIRONMENTAL HAZARDS

This product is extremely toxic to fish, birds and other wildlife. Dogs, cats, and predatory and scavenging mammals and birds might be poisoned if they leed upon animals that have eaten this bait. Do not apply this product directly to water or to areas where surface water is present or to intertidal areas below the mean high water mark.
