## **DIRECTIONS FOR USE**

SHAKE WELL BEFORE USING. Natural Guard Organic Spot Weeder Ready-to-Use is a contact, non-selective, broad-spectrum, foliar herbicide (weed killer). This means that the product must be applied thoroughly to the foliage (leaves) of weeds to be effective. This product will only control actively growing weeds. The product does not kill the roots – only those portions of the weed that comes in direct contact of the spray application. Best results are obtained when Natural Guard Organic Spot Weeder Ready-To-Use is applied to unwanted weeds when they are small (less than 6 inches in size).

Spray target weed(s) until all foliage is completely covered with the product. Foliar contact results in control of mary different types of annual grassy and broadleaf weeds (Crabgrass, Chickweed) and top growth from perennial weeds (Dandelion). Re-application is required for new weeds growing from seed, and re-growth from perennial weeds. Multiple applications will be required for control of larger weeds, or weeds that are stressed due to lack of moisture or high temperatures. Rainfall within one hour of application will reduce degree of control, and will have to be re-applied. People and pets may re-enter a treated area once an application is dry.

Note: Spray applications that contact desirable vegetation will result in injury or severe damage. Avoid contact with desirable vegetation. If product contacts desirable vegetation, wash off immediately with water.

## PRECAUTIONARY STATEMENTS

CAUTION: Causes eye irritation. Wear safety glasses when applying. Do not get in eyes, on skin, or on clothing. In case of contact, immediately flush eyes with plenty of water. Get medical attention if irritation persists. Wash thoroughly with soap and water after handling.

Keep from freezing. Store unused material, tightly closed, in original container away from children and domestic animals. Do not reuse container. Rinse thoroughly before discarding in trash.
