When a borate-based termite control product is used as the primary pre-construction treatment for subterranean termites and is applied according to label directions-for-use, **Termidor SC** may be applied as an exterior perimeter pre-construction treatment using 0.06%, 0.09% or 0.125% dilution. If the exterior perimeter pre-construction treatment option is selected, **Termidor SC** must be applied to provide a continuous treated zone along the exterior foundation of the structure. A complete and thorough horizontal pre-construction treatment with **Termidor SC** under the concrete slab is optional. **Termidor SC** may also be applied to critical areas of the interior of the structure. These areas include plumbing and utility entry sites, bath traps, shower drain penetrations, expansion joints, foundation cracks, and areas of known or suspected termite activity.

Applications must be made according to the Mixing, Application Volume and Use Instructions that apply to the selected areas to be treated that are found on the **Termidor SC** container label.
